- a) Cllr Cargill report
 - Grieg Hall - MC reported on developments the 6 months final phase.
 - Canal Quarter development scheme for Stratford.
 - Grant Scheme – applications now open. KPC to consider grass-crete for Captains Hill
 - Wellesbourne Airfield – High Court action in which judge agreed potential for development. Contrary to SDC Core Strategy. Compulsory purchase order may be an option. Value x10 for housing over airfield.
